



## Licensing and Publicity Service

After the issuance of Resolution No. 64 of 2010 regarding the conditions and procedures for licensing the establishment and operation of rehabilitation centers and institutes, care homes, shelters, and workshops for persons with disabilities, which includes in its second article a provision that no natural or legal person may establish or operate an establishment without obtaining a license to do so. Therefore, it became necessary for all old and new civil societies and private institutions to fulfil the registration requirements according to the aforementioned decision. Therefore, all old institutions, centers and institutes were addressed to fulfil the requirements of the decision and register them according to its provisions

Also included in Article 18 a provision that the Social Rehabilitation Department at the Ministry of Labour and Social Development assumes the role of monitoring the facility and make periodic visits to it to verify its services and prepares written technical reports.

The Social Rehabilitation Department, represented by the Services for People with Special Needs Section, has prepared a guide for licensing, and it includes all documents and forms necessary for licensing in addition to clear work paths for investors to facilitate access to the service, and these documents include the following:
